Felician College is pleased to offer an Injury and Sickness Insurance Plan underwritten by UnitedHealthcare Insurance Company. Eligibility Statement: All Undergraduate students taking 12 or more credit hours are required to purchase this insurance Plan, unless proof of comparable coverage is furnished. All degree seeking part time Undergraduate and degree seeking Graduate students taking 6 or more credit hours, and all students who are enrolled in the ESL program are eligible to enroll on a voluntary basis. Eligible Dependents of enrolled students may participate in the plan on a voluntary basis.
