Juniata College is pleased to offer an Injury and Sickness Insurance Plan underwritten by UnitedHealthcare Insurance Company. **Eligibility Statement:** All registered students attending Juniata College are required to purchase this insurance plan unless proof of comparable coverage is furnished. Eligible dependents of enrolled students may participate on a voluntary basis.

Insureds can also download our UHCSR Mobile App available on Google Play and Apple's App store.

Please Note: Eligible Students will be automatically enrolled and charged for the Juniata College student health insurance plan if you fail to complete an online waiver by the published deadline. The premium for the plan will be added to your tuition bill. Once enrolled, there are no refunds or cancellations except entry into the armed forces.

• IMPORTANT INFORMATION: Open Enrollment Periods for all eligible Students and dependents: If you or your dependent is eligible to purchase the annual coverage or spring/summer (new incoming or newly eligible students and their dependents only) and you choose not to enroll before the Enrollment Deadline, you or your dependent will not be eligible to enroll again until the following school year unless you experience a "Qualifying Life Event" during the year. Exclusions and Limitations

No benefits will be paid for: a) loss or expense caused by, contributed to, or resulting from; or b) treatment, services or supplies for, at, or related to any of the following:

Acupuncture; except as specifically provided in the policy;

Caffeine addiction;

- Non-chemical addiction, such as: gambling, sexual, spending, shopping, working and religious; Codependency;
- 3. Behavioral problems. Conceptual handicap. Developmental delay or disorder or mental retardation. Learning disabilities. Milieu therapy. Parent-child problems;

Biofeedback;

Circumcision;

Congenital Conditions for cosmetic purposes only;

Cosmetic procedures, except reconstructive procedures to:

Correct an Injury or treat a Sickness for which benefits are otherwise payable under this policy. The primary result of the procedure is not a changed or improved physical appearance; Treat or correct Congenital Conditions of a Newborn or adopted

Drugs labeled, "Caution - limited by federal law to investigational use" or experimental drugs;

Products used for cosmetic purposes;

Anorectics - drugs used for the purpose of weight control;

Fertility agents or sexual enhancement drugs, such as Parlodel, Pergonal, Clomid, Profasi, Metrodin, Serophene, or Viagra;

Refills in excess of the number specified or dispensed after one

Services provided normally without charge by the Health Service of the Policyholder;

Skeletal irregularities of one or both jaws, including orthognathia and mandibular retrognathia. Temporomandibular joint dysfunction. Deviated nasal septum, including submucous resection and/or other surgical correction thereof. Nasal and sinus surgery, except for treatment of a covered Injury or treatment of chronic sinusitis;

Skydiving. Recreational parachuting. Hang gliding. Glider flying. Parasailing. Sail planing. Bungee jumping;

Sleep disorders;

Speech therapy, except as specifically provided in the policy,

naturopathic services;

Stand-alone multi-disciplinary smoking cessation programs. These are programs that usually include health care providers specializing in smoking cessation and may include a psychologist, social worker or other licensed or certified professional.

Supplies, except as specifically provided in the policy;

Surgical breast reduction, breast augmentation, breast implants or breast prosthetic devices, or gynecomastia; except as specifically provided in the policy;

Treatment in a Government hospital, unless there is a legal obligation for the Insured Person to pay for such treatment; 38.

War or any act of war, declared or undeclared; or while in the armed forces of any country (a pro-rata premium will be refunded upon request for such period not covered); and Weight management, weight reduction, Nutrition programs, Treatment for obesity, Surgery for removal of excess skin or fat.
