DETAILS Lycoming College is pleased to offer an Injury and Sickness Insurance Plan underwritten by UnitedHealthcare Insurance Company. Eligibility Statement: All full-time (Domestic and International) students who are registered for 12 or more credit hours and all Fullbright Language Teaching Assistants are required to purchase this insurance plan unless proof of comparable coverage is furnished. Eligible Dependents of students enrolled in the plan may participate in the plan on a voluntary basis.

Highlights of the Coverage and Services offered by UnitedHealthcare StudentResources are:

- There is no overall Maximum dollar limit on the policy.
- \$200 Deductible for Preferred Providers Per Insured Person, Per Policy Year, \$600 Deductible for Out of Network Providers Per Insured Person, Per Policy Year.

Please Note: Eligible Students will be automatically enrolled and charged for the Lycoming College student health insurance plan if you fail to complete an online waiver by the published deadline. The premium for the plan will be added to your tuition bill. Once enrolled, premium will not be refunded except for ineligibility or entry into the armed forces.

IMPORTANT INFORMATION: Open Enrollment Periods for all eligible Students and dependents: If you or your dependent is eligible to purchase the annual coverage and you choose not to enroll before the Annual Enrollment Deadline, you or your dependent will not be eligible to enroll again until the following school year unless you experience a "Qualifying Life Event" during the year.
